GROWTH REGULATION & DISEASE CONTROL

The continuing mild conditions this Autumn means that it is imperative to review your crop regarding the use of further growth regulators. Crops that are >10cm require further treatment now.

If you missed the Plover or the Plover & Folicur application as specified in bulletin 02/16 then you need to modify your application as below:

If no Plover was applied:

Sunorg Pro	0.4 lt/ha	Apply as soon as the crop is >10cm tall					

Where Plover or Plover & Folicur were used previously; the crop is > 10 cm tall and 3 weeks have elapsed since the first application use:

LATE SEASON GRASS WEED CONTROL

For non-herbicide resistant situations leave control until Spring, but for herbicide resistant situations a Winter follow up with Crawler will be needed.

CRAWLER USAGE.

The current mild conditions are not suitable for the use of Crawler. Although application should be completed before Christmas, a delay until some cooler weather arrives is advised. Some frosty nights are required.

Crawler use can be severe on the crop, so it is worth reiterating the best way to minimise crop damage and maximise weed control:

- Ensure that the crop is a minimum of 7.5 cm (3") tall with established side branches.
- Apply in November when cool and damp.
- DO NOT tank mix with other products.
- Leave at least 3 weeks from the last application of graminicide (if used with oil) or Aramo.
- Leave at least 2 weeks after any other treatment.
- Make sure applications are completed before Christmas.

MEADOW GRASS

Situation	Product	Rate	Notes
Where high levels of Mead- ow Grass are found	Crawler	1.5 kg/ha max	For crops with side branches

DO NOT tank mix Crawler with any other product including graminicides

BROADLEAVED WEED CONTROL

Where broadleaved weed control has not yet been completed it is usually advisable to leave it now until spring
